## Finance Management specialisation

### LUXEMBOURG

The Master in Management is a two-year programme that equips students with all the necessary skills to become a well-rounded manager. The Finance Management specialisation focuses on risk assessment, auditing, compliance, and financial modelling, key areas of managerial expertise for a successful career as a professional in the field. Entirely taught in English at ESSCA in Luxembourg, the MiM combines a taught programme and practical experience, including a six-month paid internship (around €2,300 per month) during the second year of the programme.

- > End-of-programme internship, minimum duration of 4 months
- > A Master's thesis based on a concrete topic of Corporate Finance in line with the student's professional project and including significant empirical work. The thesis is written under regular supervision of a faculty member.

# Living in Luxembourg

Luxembourg City is the capital of the Grand Duchy of Luxembourg and a globally renowned finance hub. With a population of around 120,000 inhabitants, it is a cosmopolitan and multilingual city where French, German, Luxembourgish, and above all English are spoken fluently.

The headquarters of many international companies (Ferrero, ArcelorMittal, Amazon...), European institutions and renowned international banks and audit firms will provide opportunities for students to link their courses to company visits during their stay in Luxembourg.



ESSCA is the first French business school to be established in Luxembourg. The school is in Luxembourg City, about a 10-minute walk from the city centre. Several bus stops are located near the campus.

The ESSCA Alumni Luxembourg network has nearly 200 active members in internationally renowned companies such as PwC, Deloitte, EY, KPMG, BDO, Edmond de Rothschild, UBS, Bank of America, Société Générale, Banque Centrale de Luxembourg, ArcelorMittal, Arendt & Medernach, Amazon, etc.

## How to Apply?

Entry into the 1<sup>st</sup> year of the Master's programme is open to European candidates or local residents from all fields, who have completed or are likely to complete three years of higher education studies with 180 ECTS credits (or equivalent). Proof of English proficiency required: B2 minimum.

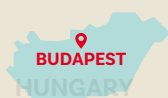
