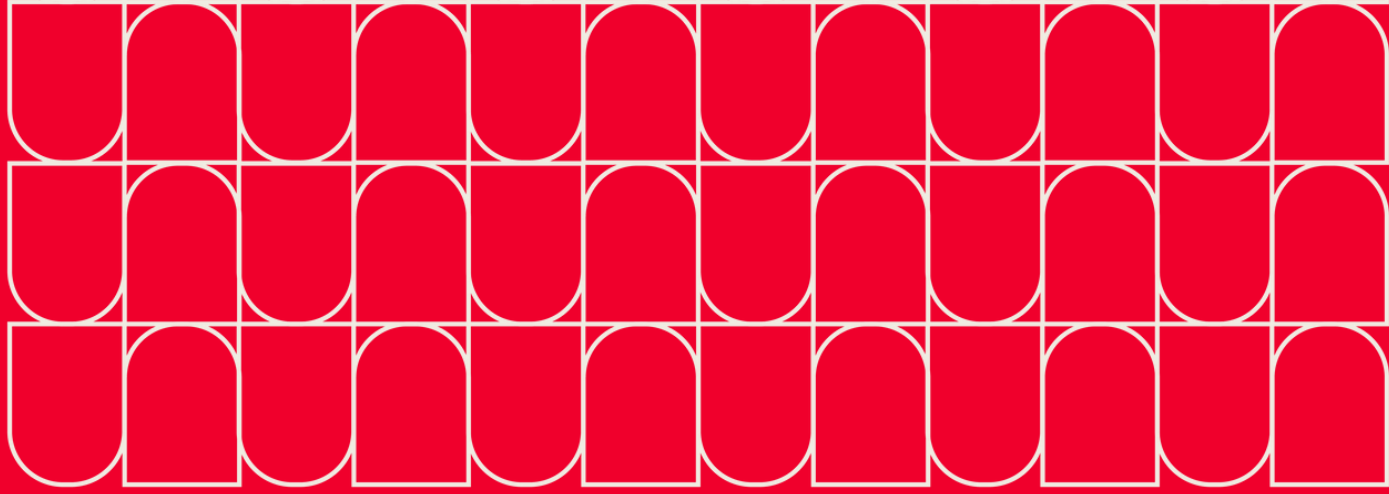

ESSCA in a few words

Founded in 1909, ESSCA School of Management prepares its students through a five-year programme to become managers in marketing, finance, and management in an international environment.

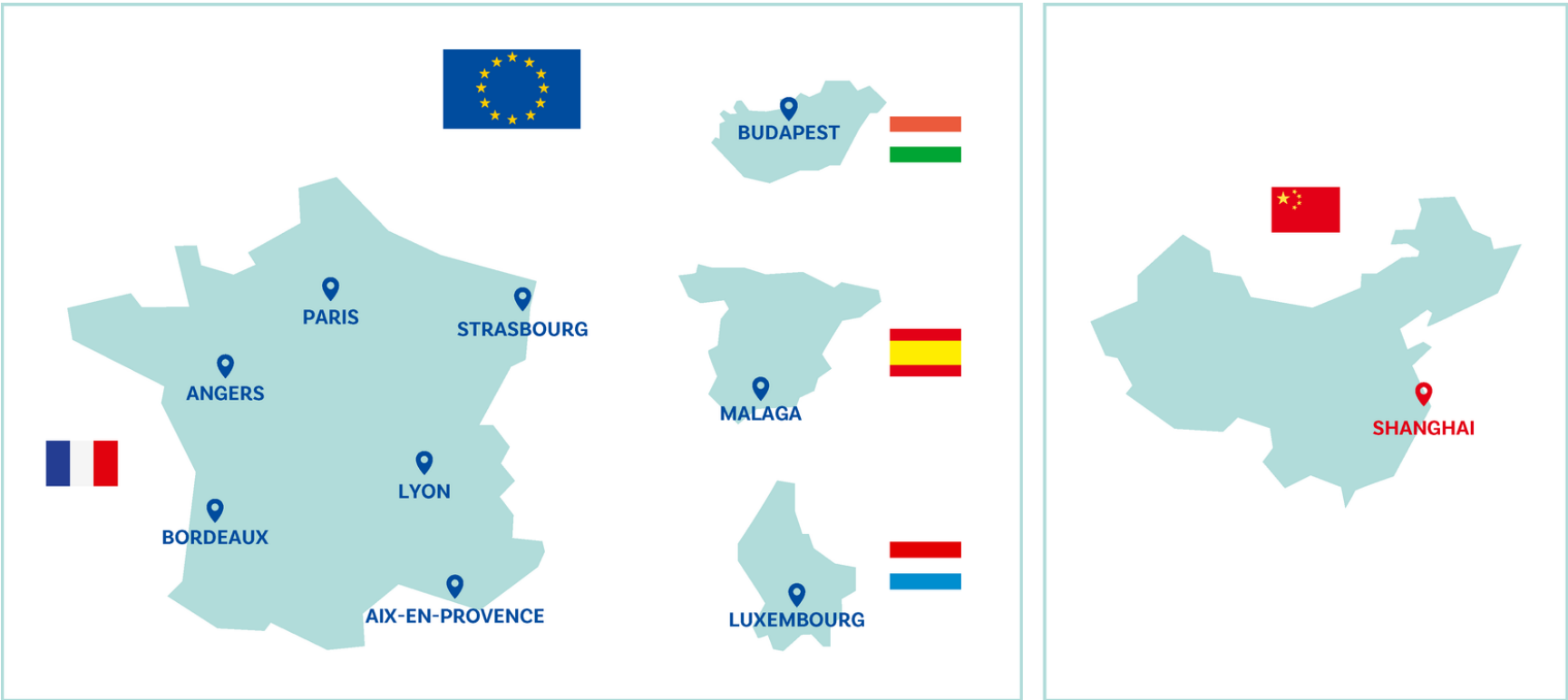
One of the post-secondary business school with international accreditation, ESSCA has been granted five « labels » of excellence: Conférence des Grandes Écoles, the Master's degree, the EPAS certification, the AACSB accreditation and the EQUIS accreditation. In 2025, ESSCA ranked 68th in the Financial Times ranking.

ESSCA offers international programmes on 10 sites: Angers, Paris, Lyon, Bordeaux, Aix-en-Provence, Strasbourg, Malaga, Luxembourg, Budapest and Shanghai, along with a network of 250 partners universities in 54 countries. At present, the school works with some 3,000 companies.

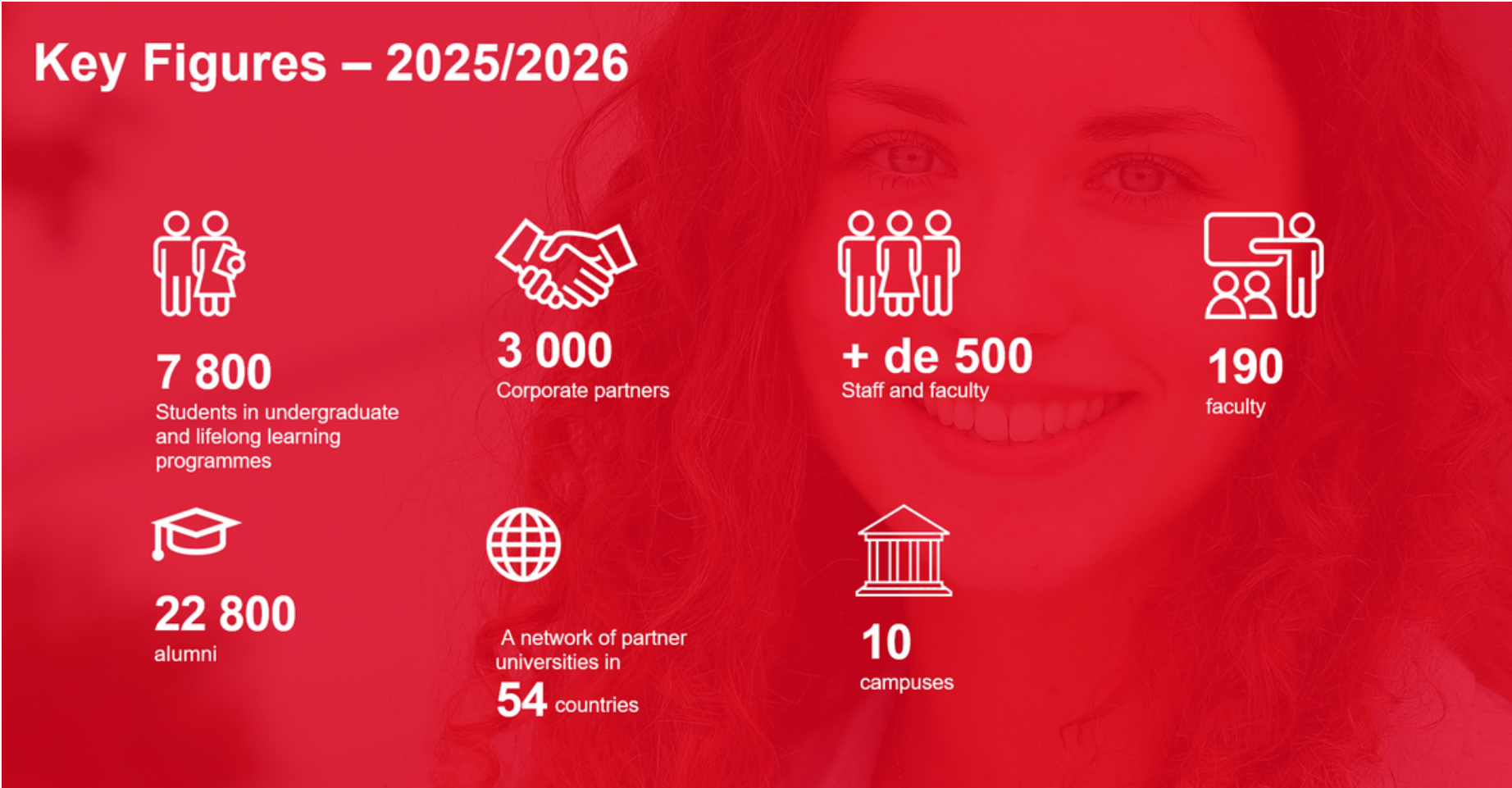


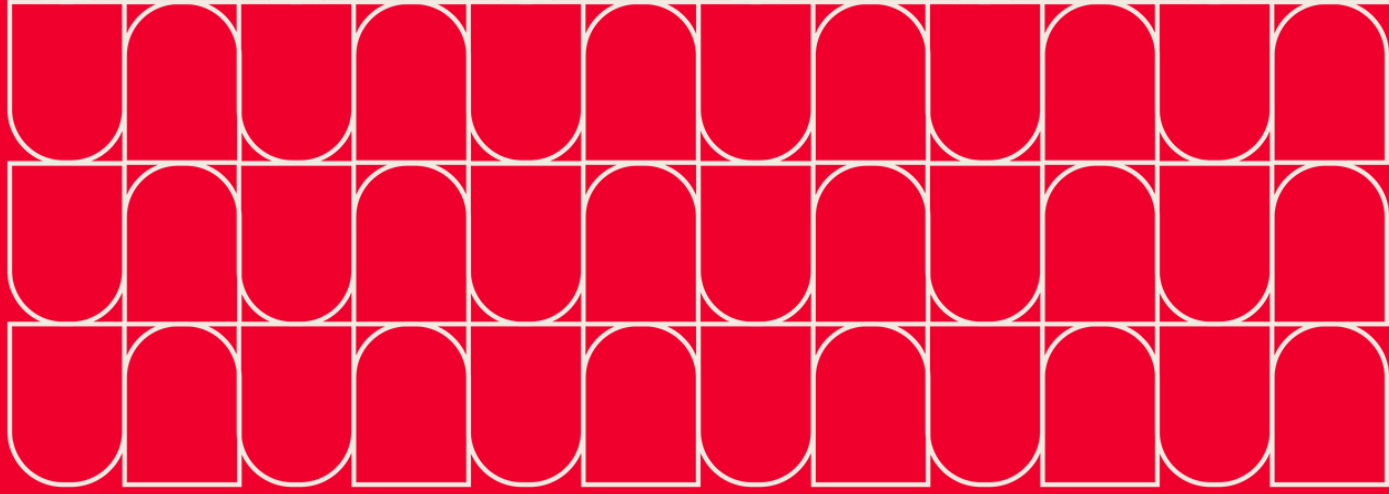

They will delve into the principles of blockchain, its applications in finance and fintech, and explore how it can shape and redefine traditional finance.

Sustainable Finance (in cooperation with EFPA – European Financial Planning Certification) and the Luxembourg Green Exchange

Mr. Patrick Levaldaur, General Secretary of the EFPA, will lead the course. It will cover various aspects related to sustainable investing, banking, and financial practices within the context of Luxembourg's finance industry. The Professor will go through the introduction of sustainable finance, the regulatory framework, sustainable investment strategies, the green financial products and services, CSR, and case studies and practical applications. In addition to the course, a certificate of participation will be delivered by both ESSCA & EFPA.

**Topic: Sustainable debt instruments role in the transition to net zero. The Green exchange intervention during the programme will focus on different sustainable debt instruments (green, social, sustainability and sustainability linked bonds) and their contribution to achieving Paris objective and the SDGs. The intervention will cover the role of stock exchanges in the transition particularly the central role of LGX in sustainable finance on local, European and international level.*

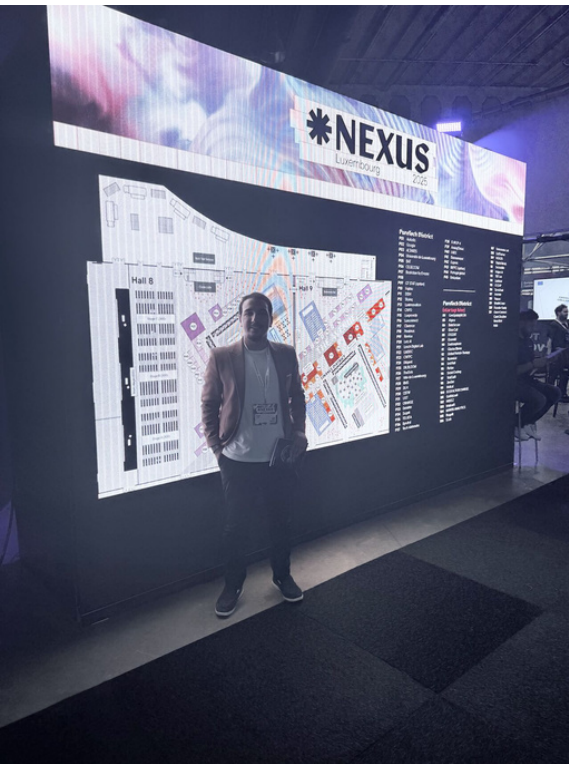

We studied sustainable finance in depth, covering ESG, regulations, and key frameworks. We also explored portfolio construction strategies, from thematic investing to negative and positive screening, aligning investments with SDG goals and regulatory frameworks. Assessing portfolios using KPIs to measure both sustainability impact and financial performance provided practical skills I'm eager to apply going forward.

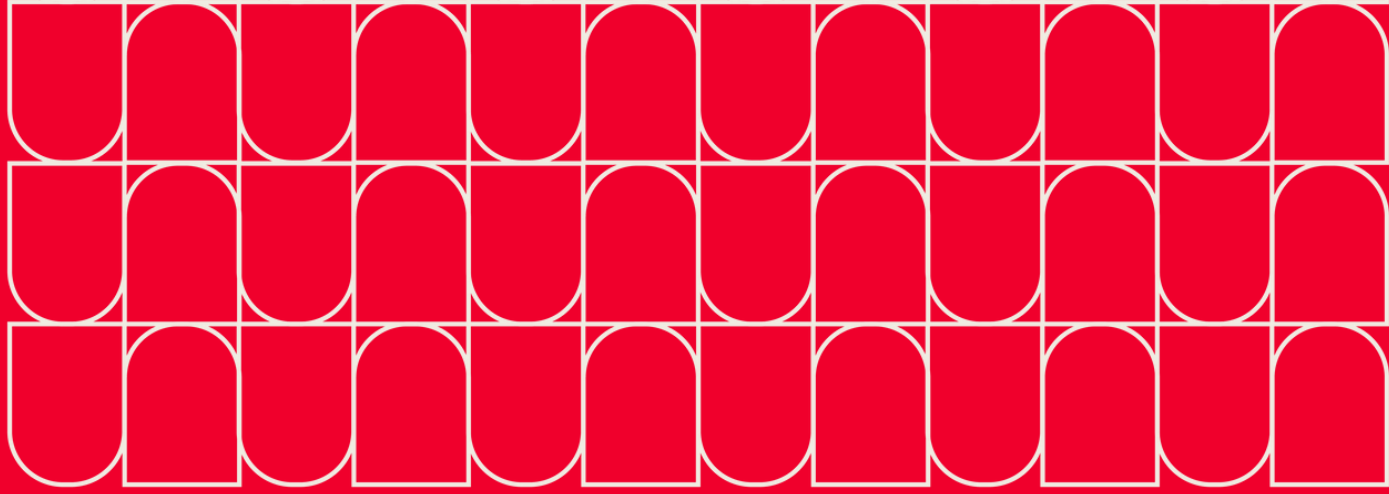

Visa

For participants from non-European countries, **student visa isn't possible** and **a short-stay visa may be mandatory**. Please ask your local study abroad advisor and/or Embassy in Luxemburg. Should a visa be necessary, it will be delivered upon proof of your official letter of acceptance issued by ESSCA following your registration.

International health insurance

Valid international health insurance or travel insurance covering hospital care and repatriation is required to fulfil your registration on the Summer Programme. Please send us a copy with your application and make sure your document is written either in French or English.

Class time and textbooks

Generally, students will have up to six contact hours per day. These contact hours also include those of the field visits which are directly subject-related. Students will not need to use particular textbooks. All material is provided by the lecturers, but a laptop is highly recommended.
